- Human Traditions to 1500.* This required introductory course explored the development of human civilization using a thematic approach. (Fall 2008, Fall 2009, Fall 2010, Fall 2011, Fall 2012, Fall 2015)
- Human Traditions from 1500.* This required introductory course explored the evolution of human civilization using a thematic approach. (Spring 2009, Spring 2010, Spring 2012, Spring 2015, Spring 2016)
- Telling Tales of the Past.* This introductory course explored the various ways that humans present the past, ranging from academic history to popular film to memorials. (Fall 2009, Fall 2011, Fall 2013, Fall 2015)

World Civilization I: History to 1500. This required introductory course explored how an ever-quickening process of globalization shaped the history of humankind from the first hunter-gatherers to the Age of Exploration. (Fall and Spring 2005-2008)

World Civilization II: History from 1500. This course explored similar themes to those covered in the first half of the sequence but began with the Reformation and concluded with the current conflicts in Iraq and Afghanistan. (Fall and Spring 2005-2008)

European History to 1500. This introductory survey examined the evolution of European society from the Greek “dark age” to the dawn of the Protestant Reformation. (Fall 2008, Fall 2010, Spring 2012, Fall 2012)

European History from 1500. This introductory survey examined the evolution of European society from the Reformation to the end of the Cold War. (Spring 2009, Spring 2013, Spring 2015)

City of the Dead, City of the Living: Histories of London: This lower-level course traced the history of life and death in London. It concluded with a 10-day trip to London. (Spring 2014)

The Holocaust in History and Memory (Historical Methods). This lower-level course examined the history of anti-Semitism, the rise of the National Socialists to power in Germany, the Nazi genocide, and the memory and legacy of the Holocaust, while also teaching students how to read and interpret translated primary sources. (Spring 2010, Spring 2012, Spring 2014, Spring 2016)

Youth Culture. This lower-level course examined the development of youth culture in the United States and Britain in the sixty years after World War II. In addition to readings, lectures, and films, it involved an experimental digital humanities component in which students created an e-Zine. (Spring 2015)

English History to 1688. This upper-level course combined a survey of English history from earliest times with questions about how history is written and presented. (Fall 2007, Fall 2009)

British and Irish History from 1688. This upper-level course traced the social, cultural, and political evolution of the British Isles by examining interaction between England, Scotland, Wales, and Ireland. (Spring 2006, Spring 2009)

Irish History: From Plantation to Tiger. This upper-level course explored both the history of Ireland as told by scholarly historians and as it is presented to tourists. It concluded with a two-week trip to the Republic of Ireland and Northern Ireland. (Spring 2010)

British Empire. This upper-level seminar explored the history of the British Empire from the seventeenth century through the present. (Spring 2013)

Postwar. This upper-level course explored the story of postwar Europe from 1945 to roughly 2011, paying special attention to issues such as reconstruction efforts and the resulting “economic miracle,” the Cold War, youth culture, nationalism, and European integration. (Fall 2011, Fall 2013)

History of Modern Tourism. This upper-level interdisciplinary course used both lectures and readings-based seminar formats to introduce students to the history of modern tourism. Students were required to undertake a significant original research project. (Fall 2004, Fall 2006, Fall 2008, Spring 2012, Spring 2016)

Nations and Nationalism in European History. This upper-level seminar introduced students to various scholarly theories of nationalism covering the Middle Ages to the present. (Spring 2008)

Historiography of Nineteenth-Century Europe. This capstone readings seminar introduced students to the basics of historiography, as well as to significant topics in nineteenth-century European history. (Spring 2007, Fall 2012)

Twentieth-Century Europe. This upper-level seminar covered various topics in the social, economic, political, and cultural history of Europe between 1914 and 1989. (Fall 2005)

Drink! Liquid Refreshment in World History. This upper-level seminar examined the role of coffee, tea, and alcohol in European and world history. (Fall 2010, Fall 2015)
